Sen. John Marty has been fighting for over 30 years, to fix our broken healthcare system. Senator Marty led numerous fights against big Pharma and their price gouging and authored numerous laws that improve our healthcare system. He has been heavily involved in the fight to address the insulin pricing crisis. John authored the **Minnesota Health Plan** to provide comprehensive, high-quality healthcare to every Minnesotan, with no exceptions. His legislation, which has received national recognition, is the only proposal that would deliver universal healthcare, and save money. Senator Marty says, "it's time to stop tinkering with healthcare reform and fix the problem," because lives are at stake.

Rose Roach is the Board Chair of Health Care for All Minnesota and recently retired as Executive Director of the Minnesota Nurses Association. Rose has over thirty years of experience in the labor movement in MN and CA. She has been a member of the Healthcare for All MN Board of Directors since its reconstitution and is the incoming National Coordinator of the Labor Campaign for Single payer.

Rose was recognized as one of Minnesota's 100 influential leaders in health care for 2016 and again in 2020. She served on former Governor Dayton's Health Care Financing Task Force and as a co-chair of the St. Paul City Task Force on Earned Safe and Sick Time. Rose was also a member of MN Attorney General Keith Ellison's Lowering Pharmaceutical Drug Prices Task Force whose final report won national Notable Document award from the National Conference of State Legislators.

Jen Crawford is the executive director of PHNP-MN*(Physicians for a National Health Program - Minnesota) and on the board of HCA-MN (Healthcare for All-Minnesota).

Jen's passion for the Single Payer movement stems from seeing multiple family members struggle to understand and pay for their healthcare. She considers herself a part of the "Underinsured Generation" and is dedicated to changing the healthcare system in America for her son's generation. Jen is proud to support the Board and members of the PNHP-MN organization.
